## **REQUIREMENTS FOR MEMBERSHIP ELIGIBILITY**

The following criteria must be met for an individual to be eligible for membership with KDD Society cannabis harm reduction association:

- A valid I.D card or residence card issued by the Maltese government
- Age must be eighteen or over
- Cannot be registered to any other cannabis harm reduction association

## **RULES AND REGULATIONS**

The following list contains several rules and regulations conforming with the authority guidelines:

- Members must be identified, including visual identification prior to being allowed to enter the premises.
- Members should present I.D card or residence card before purchasing any cannabis.
- A quota of 7 grams per day and up to 50 grams a month can be purchased by each member.
- Members must behave in an appropriate manner whilst in premises or action might be taken by the organisation if said member is in breach of the law.
- No cannabis can be consumed inside the premises as per the constitution.

## **MEMBERS OF KDD ASSOCIATION HAVE THE FOLLOWING RIGHTS AND RESPONSIBILITIES**

- The right to attend meetings and events of the Association.
- The right to vote in Association elections and on matters brought before the non-executive committee for a vote.
- The responsibility to support the mission and objectives of the Association.
- The responsibility to abide by the Association's bylaws and policies.
- The responsibility to pay any annual membership dues.

## **PROHIBITION OF DISCRIMINATION**

The discrimination based on political views, race, ethnicity, gender, religion, or any other personal characteristic is prohibited and will not be tolerated throughout all members of the association.

## **SUBSCRIPTION FEE AND AVAILABLE PAYMENT TYPES**

Our annual membership fee is 140 euros per year. This fee is subject to change and any changes are to be informed to all members. The fee is payable every three (3) months in instalments of 35 euros each.

The first instalment is due upon registration, and subsequent instalments are due on the same day every three (3) months.

If a member has not paid their membership fee within two weeks of the due date, their membership may be terminated without notice and they will not be entitled to a refund of any membership fees paid to date.

As a member, you will receive exclusive access to our product, members-only events and services including on premises support and education.

Your membership fee due quarterly includes the sale of a (2) grams of cannabis flower of your choice from our product selection.

Available payment methods for purchasing the product shall include both cash and card payments. No refunds or returns of products will be accepted, termination of membership will result in the forfeiture of any fees paid.

All payment for the products is to be made upon purchase.

## **TERMINATION OF MEMBERSHIP**

Members may resign their membership at any time by submitting a written resignation to the executive committee.

The organization may, by a unanimous decision by the members in a general meeting, terminate the membership of one of the members within the organization if the member in any way negatively impacts the organization, does not comply with the organization's goals and/or objectives as per the statute or is in breach of the law.

Upon a member's resignation, KDD Society CHRA (CHRA002) shall retain the member's personal details, including but not limited to their name, contact information, and membership history, for a period of ten (10) years. This retention is in accordance with Art 49(2) of SL 628.01, which requires the association to maintain certain records for compliance and historical purposes.

## **USE OF EMAIL AND/OR MOBILE**

KDD association recognizes the importance of timely and efficient communication with its members. To that end, the Association has established a policy regarding the use of email and mobile notifications for communication with members. Email and/or mobile notifications will be used to inform members about upcoming meetings, events, and other activities relevant to the Association. By becoming a member of the association, members consent to receive email and/or mobile notifications from the Association. Members are required to provide the Association with their email address and mobile phone number at the time of membership registration. Members may opt out of

receiving notifications on a specific platform at any time by contacting the Association. The Association will make every effort to ensure that email and mobile notifications are accurate, timely, and relevant. Notifications will be sent by a designated member of the Association's executive committee or non-executive committee and will include clear and concise language. Notifications will be sent only when necessary and will not be used for marketing or other purposes.

The Association will take all necessary measures to ensure that the collection, processing, and storage of members' personal data for the purpose of sending email and mobile notifications complies with data protection laws and regulations.

### **Confidentiality and Anonymity of Members**

We highly value the privacy and anonymity of our members. All personal information collected during the membership process will be treated with the utmost confidentiality. The association's administration is committed to maintaining the anonymity of our members and will not disclose any identifying information to any third parties, including the authority responsible for the regulation of cannabis (ARUC), unless formally requested by the Financial Intelligence Analysis Unit (FIAU) in accordance with applicable laws and regulations. The FIAU may only access the membership documents upon a formal request and as permitted by law. Rest assured that your participation in KDD Society will be kept strictly confidential, respecting your right to privacy.

### **Restriction on Cannabis Transportation Outside Malta**

Members of KDD Society acknowledge and agree that the cannabis products obtained from the association and their packaging are strictly for use within Malta. Members shall not transport or take any association-procured cannabis products or their packaging out of Malta. Any member found in violation of this policy by attempting to transport or take cannabis products outside of Malta will be subject to immediate expulsion from the association, resulting in the termination of membership and privileges.

### **Distribution Site Hours**

The distribution site is typically open for members on specific days of the week and during set hours. Additionally, the association may open for short periods outside these hours to accommodate individual member needs. Standard opening hours are from 10am till 1pm and from 5pm till 8.30pm Monday to Friday excluding Wednesday and Saturday the association is open from 10am till 3pm.

### **Stock Shortages Notification**

In the event of an anticipated shortage of stock until the next harvest, the association shall promptly inform its members. Notices will specify whether the distribution site will be closed for a limited period or will operate under shortened hours. Every effort will be made to communicate this information expediently through our social media platform and notified to members on premises.

**Stock Apportionment**

If a stock shortage occurs, the association will distribute the limited remaining stock on a first-come, first-served basis respecting the quota stipulated by law, ensuring fair distribution without unnecessary retention.

**Membership Fee Handling**

Should a stock shortage occur during a membership period for which fees have been paid, the association may determine the terms for handling these fees. If the remaining term's fee is substantial and a member was unable to purchase product for more than half the membership term paid for, members can expect compensation, such as reimbursement or credit toward the next subscription as deemed fit by the association at the time.
